PLEASE READ ALL OF THE FOLLOWING INSTRUCTIONS TO ASSURE THAT YOUR ART ARRIVES IN AN ACCEPTABLE MANNER: ON TIME, IN REUSABLE PACKAGING WITHOUT USING LOOSE FOAM PEANUTS, UNBROKEN, AND READY TO HANG SECURELY. See Shipping Instructions at the end of these instructions. Also, PLACE A TAG ON THE BACK OF 2-D WORKS (BOTTOM OF 3-D WORKS) that includes the artwork name, your name, and the price.

Please remember that (1) all work must be for sale and must be priced realistically to enhance the opportunity for sale and (2) the gallery sales commission is 38%. If the price you listed in your CAFÉ application is not appropriate, please email me with the necessary change ASAP so that I can make the appropriate artwork tags.

Also remember that the maximum size is 32 inches wide by 72 inches high—including any frame. If it shows up exceeding those dimensions, it will NOT be hung in the show.

The show will run from Thursday May 2 through Saturday June 1, 2019. If practical, we invite you to join us for the Opening Reception, Friday May 3, 2019 from 6 to 9 pm. If you can join us for the First Friday Opening Reception, please let me know so that I can have an Exhibiting Artist badge for you at the front desk.

Please plan to bring your accepted work to 311 Gallery, 311 West Martin Street, Raleigh NC 27601 during the hours of 9:00 to 4:00 Wednesday – Saturday April 24-27 or, if shipping your work, plan with your shipper to have it arrive during those hours and dates. NOTE: FEDEX ground and UPS Ground do NOT deliver on Saturdays, so try to ship work to arrive on Wednesday if using ground service. Please ask your shipper a couple of weeks ahead of time how long it will take to get from your location to Raleigh, NC—and then TAKE IT TO YOUR SHIPPER ON THE RIGHT DAY for it to arrive on the above Wednesday. Please plan carefully for shipment to us! If you send it too early, they will try to deliver too early and then put it in storage; thus, it may not get to us in time for the jury. Plan for it to get here no earlier than Tuesday; if no one is here that can take it, it will still be delivered the next day before being put into storage. If you send it too late, it won't be here in time for the jury to view.
